Executive Summary

In this report, we have summarised India's trade relations with Nepal by looking at the products imported from and exported to it, as well as India's dependence on its trade with Nepal.

India's total imports from Nepal in 2022-23 were USD 839.62 Million. India's total exports to Nepal in 2022-23 were USD 8015.99 Million.

Trade Snapshot

India imported 393 commodities identified under 63 chapters across 20 sectors from Nepal. India exported 5684 commodities identified under 95 chapters across 21 sectors from Nepal.

India's top trading sectors with Nepal are

Trade Trends

Import

India's overall imports from Nepal has changed -38.76 % from 2021-22 to 2022-23. We take a look at the change in imports from Nepal in 2022-23 over imports in 2021-22

- Sectorwise Changes
 - The Wood sector saw a 4503.7% increase in imports to 24.86 in 2022-23 from 0.54 in 2021-22
 - The Vegetable Oil sector saw a 71.59 % decrease in imports to 253.39 in 2022-23 from 891.95 in 2021-22
- Commodity wise Changes

- The commodity, Large (Amomum) saw a 28.43% increase in imports to 57.15 in 2022-23 from 44.5 in 2021-22
- The commodity Soya Bean Oil Of Edible Grade saw a 83.49 % decrease in imports to 94.13 in 2022-23 from 570.2 in 2021-22

Export

India's overall exports to Nepal has changed -16.90 % from 2021-22 to 2022-23.

We take a look at the change in exports from Nepal in 2022-23 over exports in 2021-22

- Sectorwise Changes
 - The Minerals sector saw a 13.7% increase in exports to 2921.9 in 2022-23 from 2569.75 in 2021-22
 - The Aircraft sector saw a 49.87 % decrease in imports to 391.68 in 2022-23 from 781.28 in 2021-22
- Commodity wise Changes
 - The commodity, Other Hot-Rolled Products In Coils saw a 9.46% increase in exports to 123.11 in 2022-23 from 0.13 in 2021-22
 - The commodity Strips Of Prdcts,Hot Rld,Of Thckns<4.75mm saw a 85.73 % decrease in imports to 16.53 in 2022-23 from 115.83 in 2021-22

India imported NA% of its total imports from the world from Nepal. The country is further dependent on Nepal for imports in the following ways:

Export

India exported 1.78% of its total exports to the world to Nepal. The country is further dependent on Nepal for exports in the following ways:

 - India exports 4.29 percent of its total exports to the world in the Wood sector to Nepal
 - India exports 3.47 percent of its total exports to the world in the Woodpulp Paper Pulp sector to Nepal
- Chapter (HS Code)
 - India exports 55.36 percent of products categorized under the Fertilisers. (HS Code:31) chapter from Nepal
 - India exports 7.52 percent of products categorized under the Cocoa And Cocoa Preparations. (HS Code:18) chapter from Nepal
- Commodity
 - India exports 100 percent of its total exports of Othr Vhcl Wth Cylndr Cpcty >50 Bt <= 75 Cc to Nepal
 - India exports 99.98 percent of its total exports of Othr Rice In Husk to Nepal
